


KardiaMobile® 6L—a fast and simple ECG monitoring device

ECG Device Direct-to-Patient Program

Patients can complete their ECG without a trip to the office



✓ Sign Business Associate Agreement (BAA)[†]/Attestation or enroll via the online Start Form



Fax the In-Home ECG Testing Device Request form to IQVIA at 833-781-7799



- Patient's device will ship within 1 business day via 2-day shipping
 - Patients will also receive a quick start guide and welcome call from their ECG support team to help them set up the device and run their first ECG



- QTcF results will be faxed to your office within 1 hour
 - All ECGs will be overread by a board-certified cardiologist
 - Results available by fax only. Email available upon request



✓ Inform the patient of dates they should conduct their remaining ECGs



- The patient's device will be deactivated 90 days after the patient receives the device
 - Activation extension available upon request
